

## Announcement of disposal of own shares

Brussels, 17 December 2021, 08:30 CET – Titan Cement International S.A. (Euronext Brussels, ATHEX and Euronext Paris, TITC) announces, in accordance with article 8:6 of the Royal Decree of 30 April 2019 implementing the Belgian Companies and Associations Code, the disposal by its subsidiary, Titan Cement Company S.A. (“Titan S.A.”), of 27,175 shares of Titan Cement International S.A. (“TCI”), to five (5) executives Titan Group employees, in the context of existing stock option plans.

The above TCI shares were sold on 14 and 15 November 2021 by Titan S.A., through OTC transactions, at an exercise price of € 10 per share (i.e. € 271,750 in total).

Following the above transactions, Titan S.A. owns 1,041,992 TCI shares, representing 1,33% of the voting rights of TCI.
